

**Dino's Git Down Transmission Giveaway**  
**OFFICIAL RULES ("Rules")**

**SPONSOR:** Speedway Motors, Inc., 340 Victory Lane, Lincoln, Nebraska 68528 ("Sponsor"), is solely responsible for all aspects of this Giveaway ("Giveaway").

**ENTRY:** During the period commencing at 9:00:00 a.m. CT on November 14, 2025, and ending at 11:59:59 a.m. MST on November 15, 2025 ("Entry Period"), you may enter this Giveaway by completing an entry form at the Speedway Motors booth at the Dino's Git Down car show and auto vendor expo at State Farm Stadium in Glendale, Arizona and submitting it to a Speedway employee present at the booth. The form must contain the first and last name of the entrant, mailing address, email address, and phone number. All sections of the entry form must be completed in order for the form to be considered a valid entry.

Entering the giveaway by the the method described above shall constitute an "Entry". Please print all information clearly and legibly. Illegible, incomplete, or late entries will be disqualified. By submitting an entry, you warrant that you are legally entitled and authorized to make such submission.

**LIMITATIONS:** Each Entry must be received by November 15, 2025. Entries must be made on an individual basis. Group Entries (i.e., an Entry purporting to be submitted by two or more people) will be disqualified. Open only to persons who have reached the legal age of majority in the state of residence at the time of submitting the Entry and be a legal resident of, and physically located within, one of the contiguous 48 United States or the District of Columbia (collectively, "Territory"). of winning depend upon the number of eligible entries received. In the event an alternate potential winner needs to be selected (as provided below) the same procedures will be used to select any such alternate potential winner as soon as practicable.

**WINNER:** The potential winner will be notified by phone on or about November 15, 2025, immediately after the drawing takes place.
