GENERAL WARRANTY INFORMATION

Thank you for visiting and shopping at the Edelbrock Group family of brands. Following are the terms and conditions that constitute our Warranty Policy. Edelbrock Group™ and its affiliated brands include Edelbrock® , COMP Cams®, FAST® (Fuel Air Spark Technology), TCI® Automotive, Lunati® , and Russell® Performance.

Edelbrock Group shall not be liable for any and all consequential damages occasioned by the breach of any written or implied warranty pertaining to this sale in excess of the purchase price of the product sold. If you have any questions regarding a product or installation, please contact our Tech Department toll-free at 800-416-8628 from 7:00 a.m. to 6:00 p.m. CST, Monday through Friday.

Edelbrock Group warrants each new product (except those specifically stated in sections below) to be free from defects in both workmanship and material for a period of one (1) year from the date of purchase, provided that the product is properly installed, subjected to normal use and service, and that the product is not modified or changed in any way, nor damaged because of negligence by customer or installer or used for racing or competition purposes. Customers who believe they have a defective product should return it to the dealer from which it was purchased or follow the Edelbrock Group Return and Exchange Policy to ship it directly to Edelbrock Group (also see Conditional Warranty below), along with proof of purchase and a complete description of the problem. The product must be returned freight prepaid. If a thorough inspection of the product by the factory indicates defects in workmanship or material, our sole obligation shall be to repair or replace the product. This warranty covers only the product itself and not the cost of installation or removal.

FAST® warrants that its EZ-EFI® products are free from defects in material and workmanship for the lifetime of the product. This Limited Lifetime Warranty shall cover only the original purchaser. All other FAST® products are covered by a Limited Warranty which covers defects in material and workmanship for a period of one year from the date of purchase.

FAST's obligation under this warranty is limited to the repair or replacement of its product. To make a warranty claim, the part must be returned directly to Edelbrock Group following the instructions set forth in the Edelbrock Group Return and Exchange Policy with a valid Return Merchant Authorization Number (RMA), freight prepaid. Items covered under warranty will be returned to you freight collect. To obtain an RMA, call 1-877-334-8355 to report the issue you are experiencing. At that time, Edelbrock Group will attempt to troubleshoot your issue.

It is the responsibility of the installer to ensure that all of the components are correct before installation. We assume no liability for any errors made in tolerances, component selection or installation.

THERE IS ABSOLUTELY NO WARRANTY ON THE FOLLOWING:

- Any parts used in racing applications or subject to excessive wear
