### Section 2. Hazards identification

## Section 6. Accidental release measures

#### Large spill

## procedures

: There are no data available on the mixture itself. This product contains TiO2 which has been classified as a GHS Carcinogen Category 2 based on its IARC 2B classification. For many PPG products, TiO2 is utilized as a raw material in a liquid coating formulation.
